Keynote speakers were Australian researchers Dr. Richard Tothill of the Peter MacCallum Cancer Centre and Dr. Rory Clifton-Bligh of the Kolling Institute of Medical Research. The reception celebrated a joint cancer research project between the National Institutes of Health and the University of Melbourne. This project, supported by the Alliance, seeks
